- By signing below, I acknowledge that all activities sponsored or conducted by the Mosaic Outdoor Mountain Club of Greater New York (MOMC-GNY) may be hazardous and may result in loss, damage, injury or death. With full knowledge of these dangers, I hereby agree for myself, all of my family and heirs, to release the MOMC-GNY and any of its chapters, groups, representatives or agents from liability, claims, demands or any causes of action, and not to sue or otherwise make any claim against the MOMC-GNY or any of its chapters, groups, representatives or agents whatsoever which may arise during my participation in any activities of the MOMC-GNY.
- I intend this release of liability to be effective whether or not any loss, damage, injury or death results from negligence of the MOMC-GNY or any of its agents, leaders, instructors, guides, officers, directors or representatives. I understand that negligence means a failure to do an act which a reasonable careful person would do, or the doing of an act which a reasonable careful person would not do, under the same or similar circumstances, to protect himself, herself or others from injury or death.
- I agree to be solely responsible for my own safety and to take every precaution to provide for my own safety and well-being while participating in activities of the MOMC-GNY.
